The VNR-VLR studio “Evidence-based approaches to the development of SDG Voluntary Local Reviews: experiences and best practices” will be held as a side event to the [Regional Forum on Sustainable Development for the UNECE region \(RFSD\)](#). Both in-person and online participation will be possible.

The VNR-VLR Studio is organized by the UNECE Forests, Land and Housing Division in cooperation with UN DESA, UN-Habitat and Union of Cities and Local Governments (UCLG), the partners in the project “[Voluntary local reviews: evidence for greener, resilient, and sustainable urban recovery in Eastern European and Central Asian countries in transition](#)”<sup>1</sup>; University of Geneva.

The VNR-VLR Studio will provide an opportunity for a discussion between local and national governments in the UNECE region on (1) experiences with the processes of collection of local data for the development of the VLRs/smart sustainable cities profiles and VNRs; and (2) the use of the collected data for the evidence-based policymaking, for instance, for the development of city action plans, programmes and projects. The participants will discuss how the evidence-based approach helps to accelerate achieving the SDGs on local level and support the improvement of the quality of life of people, especially vulnerable groups.
