Background and Rationale

Simultaneously in the region, there are heightened tensions that could potentially lead to further armed conflict and civilian casualties. This event addresses the crisis's resonance with SDG 16, emphasizing the imperative for States to uphold their obligations to the 'Protection of Civilians'.

The event will also explore the impact of conflict on civilians and how they are managing. Inviting civilians, international experts, governmental representatives, and civil society, the discussion aims to scrutinize strategies to mitigate civilian casualties. Participants will delve into the critical role of civil society in fostering peace and explore collaborative solutions, fostering a platform where diverse perspectives converge to tackle the urgent humanitarian challenges gripping the UNECE region.

#### **Objective:**
